Privacy Policy

The Nagasaki International Tourism and Convention Association (hereinafter referred to as the Association) recognizes the importance of personal information and believes that ensuring the protection of such is both a fundamental aspect of its business activities and a social responsibility.

Accordingly, it has set out the following protection policy for personal information and engages in appropriate and safe management of such information.

1. Complying with the Act on the Protection of Personal Information and Similar Laws
The Association complies with the Act on the Protection of Personal Information and
similar laws to ensure the appropriate handling of personal information.

2. Acquisition of Personal Information

The Association acquires personal information through appropriate and fair methods while clearly stating the purpose of use of such information.

- 1. This website acquires, in the form of access logs, information such as Internet domain names, IP addresses, and viewing of this website.
 - 2. Some pages provided by this website utilize cookies.

Cookies refer to information sent from the server to the browsers of users of this website and stored on their computers to identify them. The use of cookies makes it possible to collect data such as the number of visits by the users' computers and the pages they visit. Cookies are never used to collect information that may identify an individual user. Users can turn off the functions of cookies using the settings of their browsers. This website can still be used even if the functions of cookies are turned off.

3. Use of Personal Information

The Association only uses personal information to the extent necessary for conducting its operations, and within the scope of the purpose of use declared when the information was acquired. When, based on the consent of the individual, the Association externally contracts the handling of personal information in order to conduct its operations, it exercises appropriate supervision of the said contractor to ensure the personal information is not leaked or provided elsewhere.

Purpose of use

- (1) For contact with customers as part of the Association's operations
- (2) To request opinions and impressions
- (3) For information gathering and questionnaires
- (4) To create statistical data in such a way that individuals cannot be identified, for the improvement and enhancement of the website's services and to consider new services.

4. Provision of Personal Information to Third Parties

The Association does not provide personal information to third parties without the advance consent of the individual concerned, except for cases stipulated under the law.

5. Management of Personal Information

The Association maintains the accuracy of the personal information and manages it safely while taking security measures at an appropriate and reasonable level against threats such as illegal access to or loss, manipulation, or leaking of personal information.

6. Disclosure, Revision, Discontinuation of Use, and Deletion of Personal Information The Association recognizes the right of individuals to request the disclosure, revision, discontinuation of use, or deletion of their personal information, and immediately complies with such requests.

7. Organizational Structure

The Association has formed an appropriate management structure for protecting personal information and strives to raise the awareness of its employees regarding the protection of personal information.

8. Formulation and Implementation of Rules for the Protection of Personal Information The Association has enacted Rules for the Protection of Personal Information to ensure the appropriate and safe management of personal information. It continues to revise its systems for the management and protection of personal information as required.
